#### 2. Organizational Changes (effective April 1, 2025)

- The Innovation Center will be established as a headquarters-level organization to realize carbonneutrality and promote R&D through collaboration and co-creation. Also, the Product Development Division and the Advanced Development Division will be established under the Center, and the Group 3 Product Development Division (under the Research & Development Headquarters) will be abolished.
- The Corporate Management Headquarters will be abolished, and the Corporate Planning Headquarters and Corporate Administration Headquarters will be established.

  The Corporate Planning Division and the Business Management Division will be established under the Corporate Administration Headquarters. Also, the Corporate Communication & IR Division will be established under the Corporate Administration Headquarters, and the Accounting Division and Human Resources Division will come under the Corporate Administration Headquarters. With these changes, the Business Administration & IR Division, the Corporate Strategy Division, the Management Support Systems Division, and the Corporate Communication Division (all under the Corporate Management Headquarters) will be abolished.
- The Operations Management Development Division will be established under the Production Headquarters.
- The Customer Service Division (under the Quality Assurance Headquarters) will be integrated into the Customer Center Management Division (under the Marketing & Sales Headquarters) and renamed the Customer Management Division.
- The Machine Tools Division (under the Production Engineering Headquarters) will be renamed the Production Technology Division.
